### **Operations and Actions**

- **Agenda Approval** Mr. Stanton moved to approve the agenda. Ms. Trevisan seconded the motion. The motion carried.
- **December 20, 2017 Minutes** The minutes were corrected to add an 'r' to Treasurer. Mrs. Pappas-Wilhelm moved to accept the minutes as corrected. Mr. Stanton seconded the motion. The motion carries.

# Treasurer's Report

- Mr. Simonelli stated that soon the Vestry would receive the QuickBooks Reports with the treasurer's comments.
- The Vestry noted the Margherita Davis fund is an unrestricted fund and should be labeled as such in the Cash Summary.
- Mrs. Kent indicated there is still \$1,000 in the R.I.S.E. Mission Trip fund.
  Mrs. Kent moved to send the money in the R.I.S.E. fund to the organization. Mr. Roehrer seconded the motion. The motion carried.
- Ms. Trevisan moved to approve the Treasurer's report with the Margherita Davis fund correction. Mr. Stanton seconded the motion. The motion carried.

#### **Property Committee Report**

Mr. Roehrer reported:

- The condition of the tables and chairs are a concern. A suggestion was made to create a table and chair adopt a project.
- Mr. Roehrer will get a time frame for the work in the skylight room.
- We are leak free in the large skylight room
- The floors are being laid in the rectory.
- We will need to replace the sheet rock on an interior basement wall in the rectory.

- Ms. Trevisan moved that effective immediately the Parish checkbook is to be kept in the church office. The motion was seconded by Mrs. Kent. The motion carried.
- Ms. Trevisan moved to ratify the e-mail vote to approve Flat Rate movers bid of \$2,437 for Jon Richardson's move. Mr. Roehrer seconded the motion. The motion carried.
- Mr. Roehrer moved to ratify the e-mail vote to approve replacing the rectory flooring not to exceed \$4,500. Mr. Stanton seconded the motion. The motion carried.
- Mr. Stanton moved to have two booklets for the annual meeting. One booklet will cover the prior year and the second will cover the current year. Mrs. Pappas-Wilhelm seconded the motion. The motion carried.
